Grand Pré, North Grand Pré, Hortonville, and Lower Wolfville have a rich and varied past. **You are now invited to look to the future.**

What is the most important goal that Grand Pré and Area should set for the next 25 years? You are invited to answer this question and help set a course for your community.

In 2004, the Government of Canada recommended that this area be recognized through an exceptional designation. In 2007, a regional UNESCO Advisory Board formed to act on this recommendation and nominate Grand Pré and Area for inscription as a [UNESCO World Heritage Site](#).

To ensure that the wishes of the Community are fully understood, the Municipality is asking the Community to prepare a Community Plan INDEPENDANT of the UNESCO nomination bid.

The Goal is to develop a Community Plan that will guide the development of your Community over the next 25 years, whether or not the UNESCO nomination is successful.

The first step of the Community Plan is to establish a Community Vision that all agree to. Come help us do this on **September 18th** at Horton Community Hall.

**NOMINATION**  
*Grand Pré*

Over the next eighteen months, the regional UNESCO Advisory Board will be working toward completing and submitting a nomination dossier to the World Heritage Committee requesting that Grand Pré and Area be inscribed on the World Heritage List.

Nomination proposals are driven by local communities and describe their commitment, as well as the commitment of other stakeholders, to manage the proposed property in a sustainable manner to protect the natural outstanding universal value for future generations. It is anticipated that the Grand Pré proposal will be submitted in February 2010 for further consideration by the World Heritage Committee.

- An archaeological survey of the dykelands
- The first meeting of the 'Outstanding Universal Value' working group
- A consultant was hired to prepare an effective communication strategy

- How do we get there?

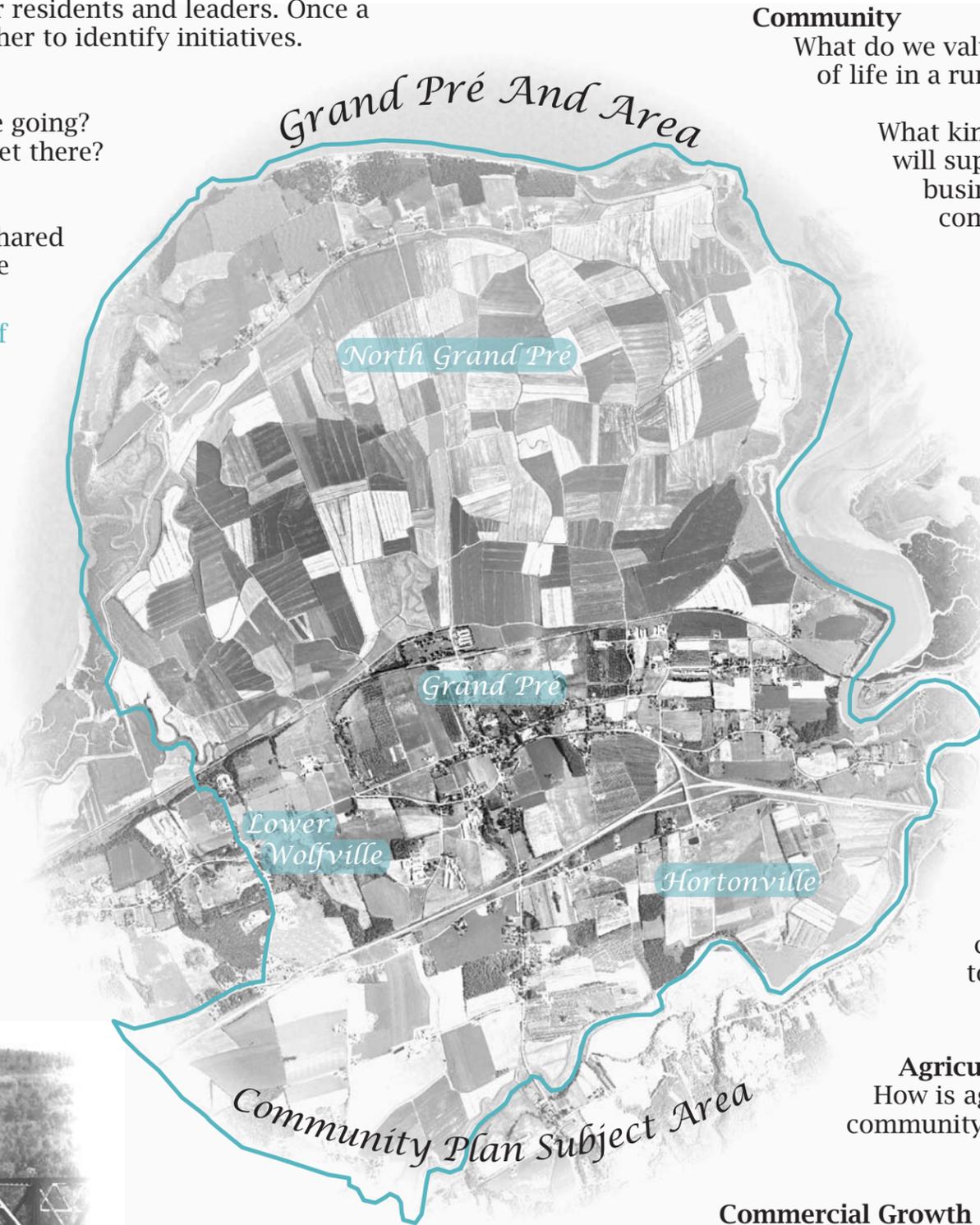
#### Shared Values Statement

The Community Liaison Group has prepared this shared values statement to guide its consultations with the Community.

The Community Liaison Group values the setting of Grand Pré and Area in a healthy and beautiful environment, sculpted and bounded by the world's highest tides and providing critical habitat for migrating shorebirds. Our historical community has an entrepreneurial and eclectic culture with shared opportunities for agriculture, recreation and a rural lifestyle, involving heritage conservation and social gatherings.

#### DID YOU KNOW?

- In 1995, the Historic Sites and Monuments Board declared Grand Pré as Canada's first rural historic district. Prior historic districts were all located within urban areas.
- Since 1981, the population has increased by 20 per cent and new units have been introduced at an average rate of four each year, with most of them being single-detached dwellings.
- Before the major highway and collector roads, the railway was the main access route for visitors to Grand Pré and Area.
